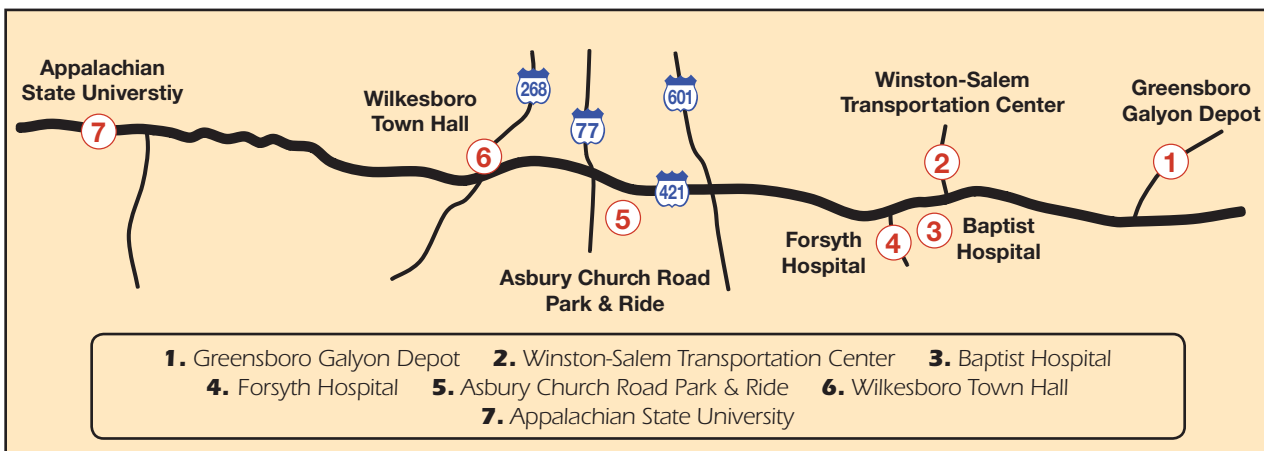


# MOUNTAINEER EAST/WEST MAP
